COVID-19 Liability Release Waiver

The World Health Organization has declared the novel Coronavirus (COVID-19) a worldwide pandemic. Due to its capacity to transmit from person-to-person through respiratory droplets, BC’s Provincial Health Officer has set recommendations, guidelines, and some prohibitions with which Prince George Cantata Singers will comply. In consideration of my participation in any Prince George Cantata Singers event, I, the undersigned, acknowledge and agree to the following:

- 1) I will not physically attend choir practices
 - o if I or any member of my household, has been diagnosed to be infected of COVID-19 virus within the last 30 days..
 - o if I am experiencing or have experienced any of the following symptoms within the last ten days: stuffy nose, fever, chills, cough, shortness of breath, sore throat, runny nose, loss of sense of smell or taste, loss of appetite, headache, fatigue, diarrhea, nausea, muscle aches, conjunctivitis, dizziness, confusion, abdominal pain, skin rashes or discoloration of fingers and toes.
 - o if I have been out of the country within the past fourteen days.
 - o if I have been in a part of Canada currently experiencing a high rate of SARS-CoV2 infections within the past 14 days.
- 2) I agree to wear a mask or face shield, in compliance with the intent of COVID-19 regulations, **at all times** while physically attending any Prince George Cantata Singers event, including while singing.
- 3) I agree to comply with any direction given by PGCS Board of Directors members or PGCS volunteers tasked with enforcing safety measures including physical distancing and wearing of personal protective equipment.
- 4) I understand that **BC’s Provincial Health Officer recommends that seniors and persons with certain health and respiratory conditions should not participate in choral singing.**

Following the pronouncements above, I hereby declare the following:

I am fully and personally responsible for my own safety and actions while and during participation and I recognize that I may be in any case be at risk of contracting COVID-19.

With full knowledge of the risks involved, I hereby release, waive, discharge Prince George Cantata Singer, its board, officers, independent contractors, and affiliates from any and all liabilities, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, injury, or death, that may be sustained by me related to COVID-19 while participating in any activity while in, on, or around the premises or while using the facilities that may lead to unintentional exposure or harm due to COVID-19.

I agree to indemnify, defend, and hold harmless Prince George Cantata singers and Trinity United Church from and against any and all costs, expenses, damages, lawsuits, and/or liabilities or claims arising whether directly or indirectly from or related to any and all claims made by or against any of the released party due to injury, loss, or death from or related to COVID-19.

By signing below I acknowledge that I have read the foregoing Liability Release Waiver and understand its contents; that I am at least eighteen (18) years old and fully competent to give my consent; That I have been sufficiently informed of the risks involved and give my voluntary consent in signing it as my own free act and deed; that I give my voluntary consent in signing this Liability Release Waiver as my own free act and deed with full intention to be bound by the same, and free from any inducement or representation.

This waiver will remain effective until laws and mandates relevant to COVID-19 are lifted.
